

REGULAR MEETING

The Hope City Council met on Tuesday, March 10, 2015 at 7:00 a.m. Present were Mayor Gary Ihry and Council members Pat Brown, Tim Johnson, Jeff Juliuson and Mike Harvey. Also present were Mike Severson, Marvin S., Karen Bergstrom and Josh Ihry.

It was moved by Juliuson and seconded by Harvey to approve the minutes of the last regular meeting. Motion carried.

Mike Severson met to request vacating that part of 3rd street north of Carpenter Ave. It was moved by Harvey and seconded by Johnson to proceed with this. Motion carried.

A dog complaint from a city resident was presented. The owner of the dog will be talked to by Brown. If the owner does not take any action, a complaint will be filed.

It was moved by Brown and seconded by Johnson to set the Hope City Board of Equalization meeting for April 14, 2015 at 7:30 a.m. Motion carried.

The Dakota Rural Water District annual meeting was discussed. Mike Harvey or Tyrone Hauge will represent the city at the annual meeting.

It was moved by Johnson and seconded by Juliuson to approve a petition from Hope Electric and Trinity Lutheran Church and set a hearing date for April 14, 2015 at 8:00 a.m. for vacating that portion of Hubbard Ave. lying between Lots 1-8 in Block 45 and Lots 17-24 in Block 46, OT City of Hope and Hope Electric for all that alley in Block 45 lying between Lots 1-8 on the north and Lots 17-24 on the south. Motion carried.

It was moved by Johnson and seconded by Harvey to approve a building permit for Hope Electric for and addition. Motion carried.

It was moved by Juliuson and seconded by Brown to approve a resolution vacating all that portion of 4th Street lying between Bates Ave and Humphreys Ave and adjacent to Lots 1 & 24 in Block 20 and Lots 12 & 13 in Block 8 in OT, City of Hope, Steele County, North Dakota. Motion carried.

Power surges at Lance Hites residents was discussed. It was moved by Harvey and seconded by Johnson to put a voltage meter on his electric system to determine where the trouble is. Motion carried.

The council discussed the Lake Agassiz block grant programs.

It was moved by Juliuson and seconded by Harvey to sell Ihry Larck Properties LLC Lots 11-12, Blk. 55 OT, City of Hope for \$100 per lot. Motion carried.

It was moved by Harvey and seconded by Brown to table a housing incentive application until certain stipulations are met. Motion carried.

County Coordinator Karen Bergstrom updated the council.

It was moved by Brown and seconded by Juliuson to pay all bills. Motion carried.
